

A regular monthly meeting of the Gilmore Township Board was held on Wednesday, March 9th, 2022 at the Gilmore Township Hall.

MEMBERS PRESENT: Gibbs, Silker, Lasher, McConnell, Marshall

MEMBERS ABSENT: None

APPROVAL OF AGENDA: A motion was made by Gibbs and seconded by Marshall to approve the agenda. All Yeas being heard the motion carries.

RECOGNITION OF GUESTS: None

PREVIOUS MINUTES: A motion was made by McConnell and seconded by Marshall to approve the February 9th, 2022 meeting minutes as presented. All Yeas being heard the motion carries.

TREASURER'S REPORT: The Treasurer circulated a copy of the Treasurer's report and read it aloud. A motion was made by McConnell and seconded by Silker to approve the treasurer's report in the amount of \$14,119.48 with check numbers 9002-9021. All Yeas being heard the motion carries.

UNFINISHED BUSINESS: A. Election update. Gibbs stated that election training has been completed by 9 election workers at this time. A motion was made by McConnell and seconded by Silker to install the ballot drop box on the porch at the township hall at a cost of \$150.00. All Yeas being heard the motion carries.

B. Township hall rehab/expansion. A discussion was held on options for building improvements at the hall. Lasher received notification from the state that the township would not be able to sell the Wahl Lake property.

NEW BUSINESS: A. Fire millage renewal. The ballot language was submitted to the county to be placed on the August ballot.

B. March Board of Review. Lasher stated that there was an increase in taxable value from 52 to 56 million.

C. Budget hearing/workshop. Date and time for the workshop is the 17th of March at 5:30 pm. Date and time for the hearing is the 24th of March at 5:30 pm. The election commission will also meet on the 24th of March after the budget hearing.

D. Property tax assessment. The increase in the property tax assessment for the wind turbines went from \$14.5 million to approximately \$30 million.

E. Independent audit. The Board discussed the audit that is to take place this year. There is an increase in the cost this year to \$4900.00.
