B. Cemetery issues. A discussion was held on regulations at the cemetery. Lasher had attended a training session on cemetery management. There was little support for adopting ordinances for the cemetery. Rules for the cemetery are not enforceable. The Supervisor also stated that the updating of the files into the BS&A software is progressing.

Coyne Oil at \$1.749 per gallon for 605 gallons. All yeas being heard the motion carried. Yeas-5, Nayes-0

**OFFICER'S REPORT:** Marshall stated that taxes are out. Silker reported that there are Civil War Veterans in the Gilmore Township Cemetery. Lasher spoke on the garbage collection service. Gibbs gave a report on the upcoming elections and training of election workers.

**PUBLIC COMMENT:** A comment was made on the cell tower located on Winn Rd and the proposed Dollar General that is going in on the corner of Winn Rd and Coleman Rd.
