

A regular monthly meeting of the Gilmore Township Board was held on June 8th, 2022 at the Gilmore Township Hall.

MEMBERS PRESENT: Gibbs, Lasher, McConnell, Marshall

MEMBERS ABSENT: Silker

APPROVAL OF AGENDA: A motion was made by McConnell and seconded by Marshall to approve the agenda as presented. All Ayes being heard the motion carries.

RECOGNITION OF GUESTS: none

PREVIOUS MINUTES: A motion was made by McConnell and seconded by Marshall to approve the May 11th, 2022 meeting minutes as presented. All ayes being heard the motion carries.

TREASURER'S REPORT: The Treasurer circulated a copy of the monthly report and read it aloud. A motion ~~was~~ made by McConnell and seconded by Gibbs to approve the report in the amount of \$30,759.35 with check numbers 9077-9090. All ayes being heard the motion carries.

UNFINISHED BUSINESS: A. Cemetery building roof replacement/cleaning. After discussion a motion was made by Gibbs and seconded by McConnell to approve Shattuck Builders for the repair in the amount of \$5,725.00. A roll call vote was taken. Gibbs-Yeas, McConnell-Yeas, Lasher-Yeas, Marshall-Yeas. The motion carries. A motion was made by Gibbs and seconded by McConnell to have the cemetery building cleaned by Patsy O'Connor for the amount of \$100. A roll call vote was taken. Gibbs-Yeas, McConnell-Yeas, Lasher-Yeas, Marshall-Yeas. The motion carries. A discussion was held on people driving thru the grass and over gravesites at the cemetery. Gibbs stated that he has tried to deter people from driving on the grass by placing driveway markers in the area where people are driving. The markers are being removed and tossed off to the side. Signs will be ordered asking people to respect the deceased and to not drive on the grass. Gibbs will also contact the Sherriff for assistance.

B. ~~B.~~ Wahl Lake property. A discussion was held on the Wahl lake property. No action was taken.

C. Meridian Road gravel project. A motion was made by McConnell and seconded by Marshall to approve the gravel contract with the Isabella County Road Commission to place gravel on Meridian road between Herrick and County line roads. This will be a 3 way split between Vernon Township and ICRC and Gilmore Township. A roll call vote was taken. McConnell-Yeas, Lasher-Yeas, Gibbs-Yeas, Marshall-Yeas. The motion carries.

NEW BUSINESS: July Board of Review, a motion was made by McConnell and seconded by Marshall to approve the July Board of review date as July 19th, 2022 at 10:00 am. All Ayes being heard the motion carries.

OFFICERS REPORT: Lasher reported that the AMAR review is coming up. Gibbs stated that the audit for the township is slated for June 15th.

PUBLIC COMMENT: A resident showed concern with the amount of brine that is placed on the roads. They do not feel that 2000 gallons of brine per mile were actually used like the contract stated. Another resident asked what contents were in the brine that was placed on the roads. One resident asked why the board was pursuing the Wahl Lake property park and showed concern with the road usage going back to the township property.

ADJOURNMENT: A motion was made by McConnell and seconded by Marshall to adjourn the meeting at 7:59 pm. All Yeas being heard the meeting was adjourned.
